

PASSPORT

Why a passport? The Dual Citizen document explains that legislation codes are in default mode. You are presumed to be in their jurisdiction automatically till one declares they are not and proves they know where their authority comes from. It is the private corporation's court, discussed further in the summons tab. The passport also offers other benefits to the holder that has knowledge how to use the passport.

The Passport is your first declaration to notify the United States that you are not passively consenting anymore to the default legislation jurisdiction. This passport will be used instead of a driver's license, gun permit, ID. for gun purchase, sales tax, pass security checks at airports, income tax, and usually will grant 15-20 percent off any insurance. Dairyland insurance is one of many, and often due to websites, insurance by passport cannot be applied for online. One may have to be a little persistent. Gun dealer, please just try it. Officer asks for a driver's license, hand him the passport and if the officer asks again for a driver's license. Say, I believe I'm in a different jurisdiction. Be careful what you say as any hesitation will give the officer suspicion and escalate his questions or enforcement.

I've personally used a passport that, when it was applied for, was marked all over it that everyone was a United States citizen and it has worked fine. Others have also and I believe it is more to make one feel they did this or that wrong when it was how one uses it that failed. Livingsovereign.org recommends filing out the new form as illustrated below. If one wants to include the following statement and is referred to as the Article 1817 Statement

I'm a United States of America National
and not a United States Citizen
Article 6, Clause 1
Article 1, Section 8, Clause 17
Article 4, Section 4
Article 2, Section 4
Let this passport reflect common law with trial by jury status

Sign and date with Notary
Send with application

When the passport is received or if one has an old passport make a copy of the picture with information on that page.

Then put the above Article 1817 statement on paper

At the end of the statement and instead of "Let this passport..."

Put:

"Sheriff, I thank you for your great service, but believe you could do a better job by knowing I'm a national."

Sign and date it

Send to the county elected Sheriff with proof of service. That is evidence the sheriff was informed and now subject to Article 2, Section 4: Impeachment Clause if violated. His job is to inform the judge that his men cannot do so because they are held liable.

ARTICLE 1817 CLAUSE should be explained:

Article 6: Supremacy, Clause 1 identifies you are honoring the compact documents: Articles of Confederation; Northwest Ordinance as one under common law and all men are equal.

Article 1, Section 8, Clause 17: Enclave Clause that as one declaring the common law limits the United States authority to D.C.; military bases; and court house and to protect one under common law.

Article 4, Section 4: The guarantee clause that United States courts have legislating codes and are to protect one after notified by United States procedures.

Article 2, Section 4: Impeachment Clause to punish civil officers when they do not honor the common law.
