PRELIMINARY UNDERSTANDINGS

Internal Revenue Service, Human Health Service, School Boards, and City Council's are all located outside the absolute jurisdiction of the United States.¹ Outside absolute jurisdiction of legislative law till one notifies the government agency or agent that they are being tyrannical and need to stop. We can depart the system and/or require the system to change for lack of equality.

CONTRACTS

Expository, Federalist paper 81:

“The contracts between a nation and individuals are only binding on the conscience of the sovereign and have no pretensions to a compulsive force. They confer no right of action, independent of the sovereign will.” No more needs said, ‘a contract only exists if the sovereign feels obligated.’

No judge, court, or civil officer can create an obligation upon the sovereign. The ticket, citation, tax notice, or summons is only as valid as the sovereign feels obligated to be a citizen of the public trust called the Constitution of the United States.

INJURY OR HARM

One is obligated and must consider the consequences. Law of equal or equity leaves one obligated to servitude for restitution. Often the death penalty for even accidents as the victim heirs plead before the courts for equal justice of one's death. Cattle rustling was death for robbing one's existence, future income, to live. No car insurance that can easily exceed one's life income would be slavery if not death. So those who self-justify their own motives will find themselves condemned by both systems: self-governing with trial by jury; legislation by codes and statues. A choice each individual must judge themselves which court they desire. Federalist papers ask the same question: why would one want to go under the verdict of a trial by jury.

The United States not granting a trial by jury leaves the United States liable for denying the law of equal rights.

Restitution will be mentioned throughout this document, but that procedure is presently being tested. The author believes restitution begins anytime the law of equal is violated, but many give grace. For a civil officer to be charged with constitutional criminal activity one must identify as a free citizen discussed in passport and other sections.

STREET-HIGHWAY OFFICERS

When stopped and asked for an ID or driver's license one hands the officer their passport. The passport is identification of being a national.² If the officer again asks for a drivers license one just politely informs the officer he has it. Any other papers brought forth indicate you're not certain whether you want legislation or self governing or as often said suspicion of what one is. If one has a driver's license best to just take the ticket and then file according to the summons tab. Do not argue as you will always lose. I've personally told them that we need to go have the judge settle this disagreement. They never took the challenge.

IRS

Aaron Russo, Freedom to Fascism movie, asked the IRS if taxation was volunteering, yes. Asked if the IRS would come after one for not volunteering, yes. This is explained in the opening remarks to this forum.

Employers

W-4 instead of SS number use your passport number. Then fill out part 1 and file for yourself only. Just below 4-C there is a blank space: national

The IRS form calls us NRA or non-resident aliens, but a few employers take issue with that. So, communication skills are required for self-governing this part. Otherwise, one can put the NRA in the space. That should be sufficient, but sometimes refused, but adding either form 8233 or W-8BEN form does the trick. Some people have used the W-8BEN or 8233 by itself.

So if rejected with communications ability by the employer write to the IRS commissioner sending him the information and reporting the employer refuses to take your form.

One can also fill out a 1040 NR form for last year's tax to be returned in full. Not known, but believed one could go back three years as the IRS goes back three years.

This form is the easiest.

For those self-employed

Stop filing returns and send copy of passport and Article 1817 statement with this addition: tax exempt to the IRS commissioner to hold that individual position personally responsible for any harm by a civil officer.

Any mail sent to you inquiring information of your income tax or charges that one owns requires one to make a copy of the document and attach Article 1817 Statement.³ Send to the IRS commissioner and to the agent the document came from. This is valid for everyone to do. Even if you did not inform the agents and agency prior to your new status of non participation. If not notified prior? This is your notification you are opting out now.

HUMAN HEALTH SERVICES

This organization is brutal at handling everything about health. Mask mandates for schools, mask mandates for stores, etc. Medical has gone crazy under the authority of this agency. All these facilities are not in the absolute jurisdiction⁴ of the United States.

Therefore, under the common law of equal law. Entering a store or school and being told to put on a mask requires a question, (record for evidence) "Is this a store policy?" If they say, yes, you have to obey and leave or do further investigation to show the owner lied. If they say it is a government requirement, creativity helps here.

Thoughts or approach

First the passport and state you have political immunities. The store manager insists. Politely request them to call the sheriff or authority to give one a ticket while you quietly wait. When the authority arrives, they usually look at the store owner and say, trespassing? Immediately correct that by stating, "wait a minute the owner said it was a mask mandate and you're changing the claim." If it was trespass, I would have left, but now I need a ticket from you, civil officer, for me

violating the code of a mask mandate.”. Also, inform him politely with your passport that you have political immunities. Twice the officer walked out, but if I was issued a ticket, one would follow the summons tab procedure.

ELDERLY HHS

Often elderly go to nursing homes and the HHS then swap service and upon death take the home or a good portion of the home for their service. It is your conscience to decide to stop the agency or not. Case in point.

Elderly lady with Alzheimer's made her two sons, co-tenants. One 😊 stayed and took care of her for ten years. Paying maintenance, mortgage payments, insurance and often extras for his mom. The other son 🙄 went his way with no thought of the bills. That son 🙄 went to the hospital where he died several years after mom, but HHS claimed half the home or pay the hospital bill. 🙄 tried to claim in the court the bills he paid in those years are his brother's debt and owed to him, but the court would not hear it.

HHS took the first 😊 to court to force a sale. The 🙄 did not have money to pay the bill and at 83 did not want to move since he was also still operating a key business out of the home. So filed an article 1817 on the case with the court clerk. The court ordered eviction, notified they sold the home, but removed the HHS lien and stopped the foreclosure and eviction with the sheriff. So the IRS stepped in line waiting with a \$42,000 lien. Filed Article 1817 on the IRS and it was honored also. That is an article 1817 to the agent and the IRS commissioner for lack of jurisdiction. 🙄 is happy.

GUN PURCHASE

The Rules are changing along with the forms so always be prepared to adapt. If one tells the gun shop to use the passport as I believe it will go through. It appears the CBI or Colorado Bureau of Investigations has not stopped that. Maybe other states also. One will need to go and explain or write a letter to clarify. If the CBI or agency in your state refuses, then get the name of the individual who made that decision. Then a letter to the House Committee on the Judiciary is in order for violating the law.⁵ Constitutional law⁶ where the civil servant is to protect you from these political codes interfering with one's liberty.

Understanding the rules and one's persistent position using tact will go the distance to educating the Civil servants and easier on the next sovereign coming along.
