## Constitutional Republic History

*Galatians 5:22-23 says this: "But the Fruit of the Spirit is love, joy, peace forbearance, kindness, goodness, faithfulness, gentleness, and self-control. Against such things there is no law."*

*GEORGE WASHINGTON*

*"Let us therefore animate and encourage each other, and show the whole world that a Freeman, contending for liberty on his own ground, is superior to any slavish mercenary on earth."*

*Mercenary defined as primarily concerned with making money at the expense of ethics  
Slavish defined as lacking in independence or originality*

On June 17, 1775 George Washington became the Commander and chief of the Continental army and left days later to Cambridge, Massachusetts to take command.

On June 11, 1776, the Second Continental Congress appointed three concurrent committees in response to the Henry Lee Resolution: one to draft a declaration of independence, a second to draw up a plan "for forming foreign alliances," and a third to "prepare and digest the form of a confederation." Confederation meaning an agreement between nations or sovereigns.

Then George Washington, a man of prayer, retreated to Valley Forge and there his prayer led to a prophetic vision known as "son of the republic". This was a creator's command and inspired his efforts to fight and remove a tyrannical government with the republic in mind as a confederation that all men are free and can be no freer.

The compact documents created by men are the first three of our organic laws:

- The Declaration of Independence
- Articles of Confederation
- Northwest Ordinance

*"Trial by jury cannot be considered as a natural right, but a right from a social compact which regulates the action of the community, and is as essential to secure liberty of the people as anyone or the pre-existent rights of nature."*

Upon winning the war and the signing of the Treaty of Paris: George Washington stated to The States, 8 June 1783 - "At this Auspicious period the United States came into existence as a Nation, and if their Citizens should not be completely free & happy, the fault will be their own"

George Washington never surrendered that vision and we pray to restore that for all Americans who wish to see the vision of the republic.

The Daniel Shay Rebellion forced the union to recognize a more central government was needed. If the United States of America could not defend insurrection within, how will America defend from invading nations? So, the Constitution of the United States created a central government that our forefathers saw as a necessary evil.

“A lady asked Dr. Franklin, Well Doctor what have we got, a republic or a monarchy – A republic replied the Doctor, if you can keep it.”

What we really have is a Constitutional Republic:

In a pure democracy, laws are made directly by the voting majority leaving the inherent and compact rights of the individual largely ignored and trampled. The minority is forgotten and abused. Legislative codes are made by representatives chosen by the people or bought by business for politicians' votes. People that prefer safety by democracy will eventually be pressured by the tyrannical government of mobocracy to poverty and ankle bracelets. Looking for handouts instead of prosperity.

Those that enjoy liberty must know the Constitution is the law to defend and protect the minorities and liberties. It is the duty of the people to study and know their trust (Constitution of the United States) and defend their liberty as the trust guarantees one as the beneficiary of a republic form of government as the compact agreement describes. The Constitution guarantees a republic form of self governing.

No monarch can exist in America, but the Republic as seen in the compact documents was left to the people to defend by the words, "if you can keep it" <sup>1</sup> or "can be used against the United States."<sup>2</sup>

Most American so-called sovereign citizens<sup>3</sup> believe the republic requires the government is to endorse or enforce the republic liberties, but this is false and what is liberty when it is required by force? The legislative central government carries out the will of democracy or mobocracy and the lobbyists wills of special deals. It is for a sovereign to defend his liberty with the protections guaranteed by the United States. <sup>4</sup> Show others the animation of living in the spirit of being free.

President Lincoln's civil war was sold as freeing the slaves and in reality it was creating a tyrannical government. The Commander and Chief by executive order 100, Lieber Code, Article 13, declaring war on the free people, by denying a trial by jury, and creating court-martial legislative military courts. A very tyrannical government by denying self rule, listen to the following.

19 July 1867 President Andrew Johnson a southern Democrat that became president upon Lincoln's death vetoed the reconstruction act <sup>5</sup>. The following is the closing words.

"is interference with the constitutional authority of the executive department is an evil that will inevitably sap the foundations of our federal system; but it is not the worst evil of this legislation. It is a great public wrong to take from the President powers conferred on him alone by the Constitution, but the wrong is more flagrant and more dangerous when the powers so taken from the President are conferred upon subordinate executive officers, and especially upon military officers. Over nearly one-third of the States of the Union military power, regulated by no fixed law, rules supreme. Each one of the five district commanders, though not chosen by the people or responsible to them, exercises at this hour more executive power, military and civil, than the people have ever been willing to confer upon the head of the executive department, though chosen by and responsible to themselves. The remedy must come from the people themselves. They know what it is and how it is to be applied. At the present time they can not, according to the forms of the Constitution, repeal these laws; they can not remove or control this military despotism. The remedy is, nevertheless, in their hands; it is to be found in the ballot, and is a sure one if not controlled by fraud, overawed by arbitrary power, or, from apathy on their part, too long delayed. With abiding confidence in their patriotism, wisdom, and integrity, I am still hopeful of the future, and that in the end the rod of despotism will be broken, the armed heel of power lifted from the necks of the people, and the principles of a violated Constitution preserved."

"The remedy must come from the people themselves." as stated above and livingsovereign.org will explain the remedy process throughout this site. The United States Supreme Court has stated in favor of the Constitution the guardian of the republic.

While an emergency cannot create power and no emergency justifies the violation of ANY OF THE PROVISIONS of the United States Constitution or States constitutions.

Congress by, 4 U.S.C. Chapter 1, §§1, 2, & 3: the flag does not have a gold fringe for the people in the free Republic, as declared by Congress.

Only by executive order as military Chief and Commander, with an Executive Order 10834, August 21, 1959; 24 F.R. 6865, was given 3 sides of the flag a gold fringe. A flag by Commander and Chief as ordered for the military.

This flag is displayed on every vessel of the United States public establishments. Declaring war, and treason, against the United States of America and the sovereign authority of the people. Holding a trial by jury captive from the people. In direct violation of Federalist Paper 81: no appellate court can deny a trial by jury.
